

RCUK Learning Management System (LMS) User Policy

The Learning Management System (LMS) (www.lms.resus.org.uk) website is maintained by Resuscitation Council UK (“RCUK”). RCUK is a registered charity, number 1168914 and its office is at 60-62 Margaret Street W1W 8TF.

By accessing this website, you agree to be bound by these terms of use.

1. Personal Data and Security

- 1.1 RCUK is committed to keeping all personal information secure and confidential. This website has a Secure Socket Layer (SSL) certificate, meaning a secure system infrastructure is in place.
- 1.2 All personal data processed in connection with the use of the LMS is processed in accordance with the Data Protection Act 2018, and the RCUK Privacy Policy can be found [here](#).
- 1.3 When you register on the site, RCUK collects the following personal information from you:

Email; First name; Surname; Year of birth; Ethnicity; Communication preference A; Communication preference B; Is English your first language; Location of professional training (if applicable); Professional registration organisation; Professional registration number; Place of work; Job title; Job grade; Job specialty.

This information allows RCUK to:

- administer courses
 - audit usage of the site
 - conduct research regarding future training needs
 - produce statistical information relating to the use of the site. This statistical information does not contain any personal identifying information.
- 1.4 The personal details available on the LMS are strictly confidential. Course centre personnel agree to use the data obtained from the LMS in a fair and lawful manner solely for training and administrative purposes related to RCUK. Course centre personnel agree not to sell individual information and not to share the information with any other organisation or individual unless RCUK has given them prior written consent to do so.
 - 1.5 On receipt of bona fide requests for information from authorised bodies such as NHS Trusts or employment agencies, in relation to confirmation of a data subject's course attendance or

qualification, RCUK shall confirm validity of the data subject's course certificate and dates of attendance.

- 1.6 The RCUK LMS is hosted in the European Economic Area using AWS (Amazon Web Services) and all data is stored within the same region. AWS will only store data in the designated region and it is stored in line with the AWS GDPR DPA.
- 1.7 The LMS requires users to have cookies. This is to manage session information while the user is logged in. These are temporary cookies rather than permanent ones, which means that no critical or sensitive information is stored. Further information on RCUK Use of Cookies can be found [here](#).
